

SUMMARY

The 4th Joint Meeting of The ASEAN Plus Three Field Epidemiology Training Network (ASEAN+3 FETN) with The ASEAN Veterinary Epidemiology Group (AVEG) hosted by Lao PDR during 14 - 15 December 2021

Referring to the 11th ASEAN + 3 FETN steering committee meeting held on 13-14 January 2021 hosted virtually by the ASEAN + 3 FETN Coordinating Office. All ASEAN + 3 FETN steering committees agreed to conduct the fourth Joint Meeting of The ASEAN Plus Three Field Epidemiology Training Network (ASEAN+3 FETN) with The ASEAN Veterinary Epidemiology Group (AVEG) for strengthening collaboration and inclusiveness in enhancing the collaboration of applied field epidemiology capacity between ASEAN + 3 FETN and AVEG to prepare for mitigating the consequences of life-threatening zoonotic infectious diseases.



To prevent an outbreak and avoid the loss in the ASEAN member countries timely and efficiently, the multisectoral and multidisciplinary collaboration between epidemiologists from the public health sector and the animal health sector is needed to strengthen regional and global health security. The said meeting was held on 14 and 15 December 2021. From 09:00 – 12:00 AM ICT time (GMT+7).

The host of the workshop is Lao PDR by facilitated by the ASEAN Secretariat, ASEAN Plus 3 FETN Coordinating Office, Office of International Cooperation Thailand and ASEAN Plus Foundation. The web conference software, "Zoom", was used.

Day 1: 14 December 2021: Closed Session

1. Chair: Dr Rattanaxay Phetsouvanh, Chair of ASEAN Plus 3 FETN Steering Committee

WELCOME REMARKS

2. The Day 1 FETN-AVEG meeting 2021 was chaired by Dr Rattanaxay Phetsouvanh, Director General of Communicable Diseases Control, Ministry of Health Lao People's Democratic Republic and Chair of ASEAN Plus 3 FETN Steering Committee. He extended a warm welcome to all participants. He outlined the objectives of the meeting, which were to share updates, information, and lessons from the COVID-19 response by ASEAN+3 FETN and AVEG, to review the progress of implementation on the existing agreed joint activities between ASEAN+3 FETN and AVEG from 2016 – 2020, and to develop the 5-years strategic framework of cooperation (2021-2025) between ASEAN+3 FETN and AVEG.



ROLL OF INTRODUCTION

3. Mr Chair invited the Assistant ASEAN Plus 3 FETN Coordinator, Dr Arisara Choochern, to do a roll call and ask all participants to introduce themselves briefly.

ADOPTION OF MEETING OBJECTIVES AND THE AGENDA

4. Mr Chair invited the ASEAN Plus 3 FETN Coordinator, Dr Komchaluch Taweeseeneepitch, to outline the meeting objective and the agenda to let participants understand. All participants agreed with no objection to all objectives and meeting agenda. See more detail in Annex 1.

Agenda Item 1: UPDATES FROM THE ASEAN HEALTH SECTOR AND ANIMAL HEALTH SECTOR ON THE STRATEGIC DIRECTION FOR 2021 – 2025

5. Dr Michael Glen from Health Division – ASEAN Secretariat gave the overview of the outcomes from relevant ASEAN Meetings and the development of the ASEAN Coordinating Centre for Animal Health and Zoonoses (ACCAHZ). He highlighted that the joint activities between ASEAN Plus 3 FETN and AVEG are in line with Strategic Thrust 2: Disease control and food safety to expand trade and protect human health. The potential activities are addressed in activity 2.1.2. Increase capacity development in Veterinary Epidemiology and undertake relevant epidemiological works. He mentioned the objective of developing the ASEAN Coordinating Centre for Animal Health and Zoonoses (ACCAHZ). The general objective is to establish and sustain a regional mechanism that will facilitate coordination and cooperation among AMS and relevant national and international partners and stakeholders to prevent, control, and eradicate transboundary animal and zoonotic diseases in the region. 

Agenda Item 2: SHARING OF BEST PRACTICES, EXPERIENCES, AND LESSONS FROM ASEAN+3 FETN AND AVEG IN RESPONDING TO COVID-19


8. Dr Chawetsan Namwat, the Director, Division of Disease Control in Emergency Situation, Department of Disease Control, Minister of Public Health from Thailand, shared the best practices, experiences, and lessons on responding to the pandemic COVID-19. He announced that Thailand won United Nations Public Services Awards. He emphasized that the success factors in COVID-pandemic control compose staff, staff and system. The disease control policy in 2020 is to prevent infection, whereas the disease control policy in 2021 is to prevent death. See more detail in Annex 4. 9. Dr Kevin Lim, the Director of Veterinary Health Management Branch from Animal and Veterinary Service of National Parks Board from Singapore. He presented the roles of veterinary professionals to be in charge of responding COVID-19 pandemic. He highlights wildlife's surveillance and monitoring systems, such as the bio surveillance program. The concern is about the resurgence of the COVID-19 pandemic. COVID-19 created disruptions and generated uncertainties for animal industries, veterinarians, pet owners and the public. One Health Multi-Sectorial Collaboration is the most critical approach. Multi-agency workshops and discussions organized to drive a whole-of-government biosurveillance framework to address diseases of public health concern. Sharing from veterinary and human epidemiologists with field officers from various disciplines and job scopes could enhance the development of the One Health Field Epidemiology Course. Biosurveillance Programmes

- Since 2011, NParks and researchers have been collecting samples from bats and other wildlife to test for a number of viruses.
- Increased public awareness of biosurveillance programmes to monitor animal diseases
- Public communications on the risks of wildlife and how to minimise human-wildlife conflict
- Importance of sustained and regular disease biosurveillance




NParks: Coronavirus not found in bats and other animals in Singapore so far

10. Dr Siti Ganefa Pakki from Indonesia shared the Indonesia public health in responding to COVID-19. She concluded that critical of one health approach. Indonesia has three pillars to respond and mitigate the COVID-19 pandemic as follow; 1) prevent such as joint risk assessment, 2) detect such as Disease prevention at the port of entry for both human and animal and 3) respond such as Risk Communication. Agenda Item 3: REVIEW AND UPDATES ON THE PROGRESS OF THE IMPLEMENTATION OF JOINT AGREED ACTIVITIES OF ASEAN+3 FETN AND AVEG (2016 – 2020).

11. Dr Komchaluch Taweeseeneepitch, ASEAN Plus 3 FETN Coordinator, reported the progress of the jointed activities, which got the concurrent from the three previous joint meetings. He announced the joint training activities in 2022: joint tabletop exercise & guideline development and a Joint training workshop on policy communication held in February 2022. Agenda Item 4: DISCUSSION ON THE 5-YEARS STRATEGIC FRAMEWORK OF COOPERATION (2021 – 2025) BETWEEN ASEAN+3 FETN AND AVEG.

12. Dr Michael Glen from Health Division – ASEAN Secretariat presented the draft version of the 5-years strategic framework of cooperation (2021-2025) (see more detail in Annex 8) to all focal points from ASEAN Plus 3 FETN and focal points from AVEG. Mr Chair opened the floor for discussion and asked for feedback. All participants actively participated and asked questions during the presentation. Finally, Mr Chair summarized that there are no more comments and feedback from the meeting. The meeting agreed to let Health Division-ASEAN Secretariat, FAFD – ASEAN Secretariat and ASEAN Plus 3 FETN Coordinating Office distribute the drafted version to all focal points to get concurrent/Ad-referendum by the second week of January 2022.

Agenda Item 5: ONGOING AND FUTURE PARTNERSHIP WITH DEVELOPMENT PARTNERS

13. The Day 2 FETN-AVEG meeting 2021 was chaired by Dr Rattanaxy Phetsouvanh, Director General of Communicable Diseases Control, Ministry of Health Lao People's Democratic Republic and Chair of ASEAN Plus 3 FETN Steering Committee. He welcomed all valuable participants. He presented the agreed 5-years Strategic Framework between ASEAN Plus 3 FETN and AVEG from the first day. The overall objective of the Strategic Framework was addressed (Annex 9). The project activities in each program objective are elaborated. He opened the floor for discussion and pointed out the concerns for notation and consideration for developing partners.

14. Dr Masaya Kato, the WHO SEARO, gave the presentation. He overviewed the roles and works of SEARO to the health emergency program by strengthening regional alert, preparedness and responses. He mentioned supporting the collaborative FETN and AVEG activities by strengthening FETP and epidemiologist and public health workforce, enhancing information sharing and exchange, and supporting epidemiological investigation and study through WHO Collaborative Center as requested. 15. Miss Jenifer Lai from Global Affairs Canada gave the presentation. She mentioned that the collaboration with ASEAN is against the spread of weapons and materials of mass destruction. The large scale of infectious disease is the most concern of biological threat. In addition, most new emerging infectious diseases came from wildlife animals. Therefore, the development of joint field epidemiology capacity is needed. Mitigation of Biological Treat (MBT) program support health security purposes from 2014 to 2022. Global Affairs Canada is willing to strengthen global mechanisms for responding to & investigating deliberate use of disease. See more detail in Annex 11. Dr John MacArthur, Regional Director of CDC Southeast Asia Regional Office, presented the collaboration with ASEAN plus 3 FETN is to support workforce development by providing regional FETP technical advisor and One Health-based activity through regional One Health technical advisor. US CD signed the cooperative agreement with ASEAN Plus FETN Foundation to implement ASEAN Plus 3 FETN activities for 5 years. 
